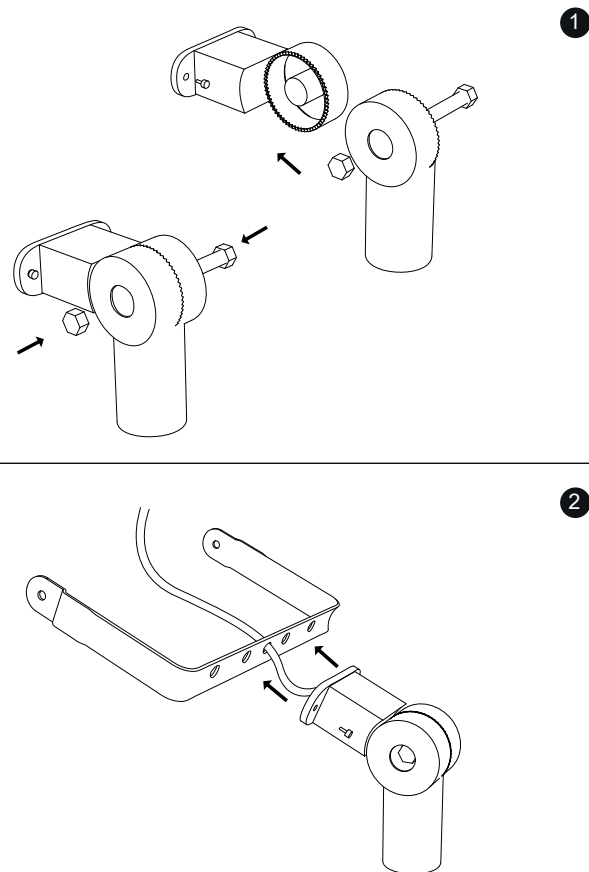
- Beleuchtungseinrichtungen dürfen nicht als normaler städtischer Abfall behandelt werden.

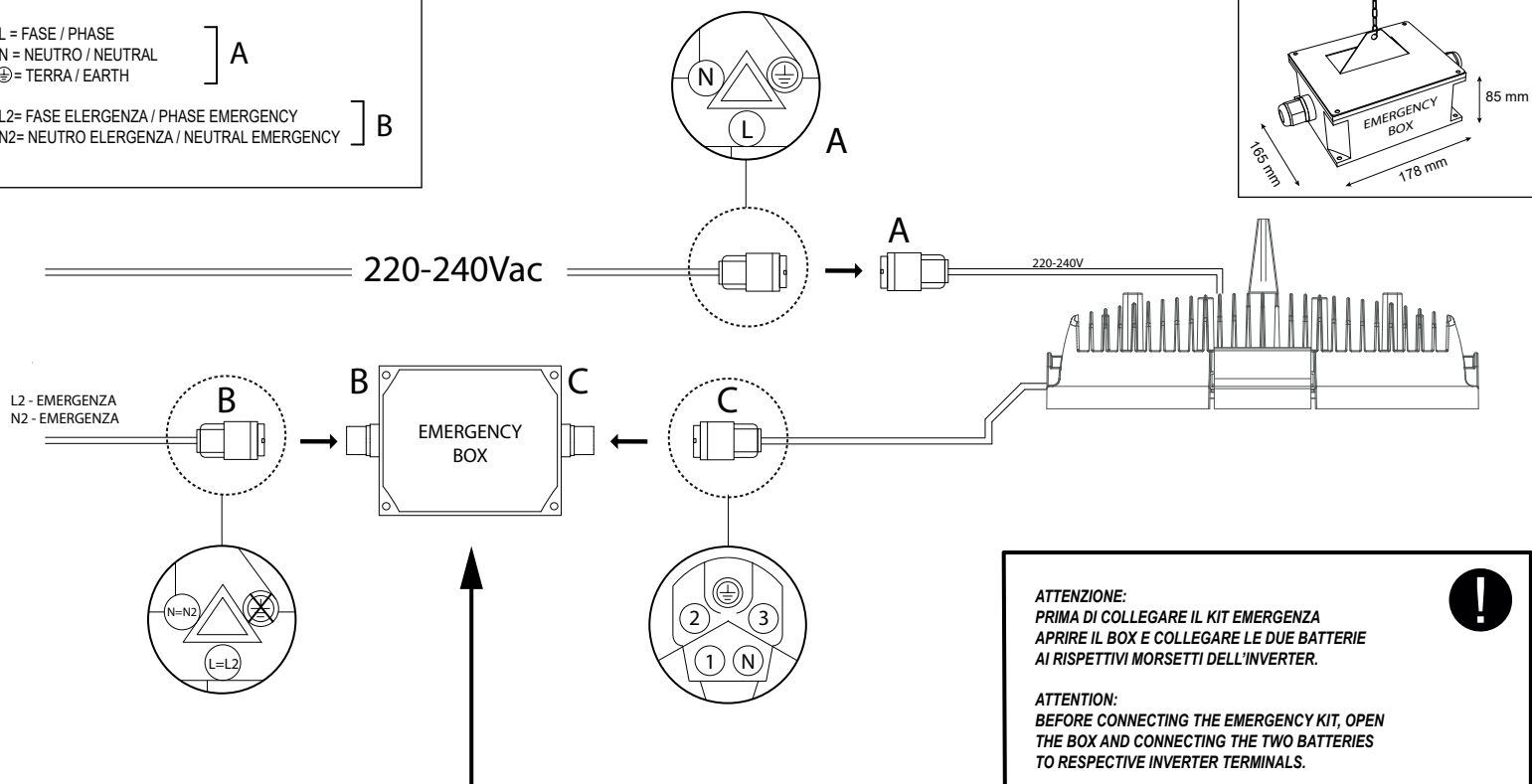

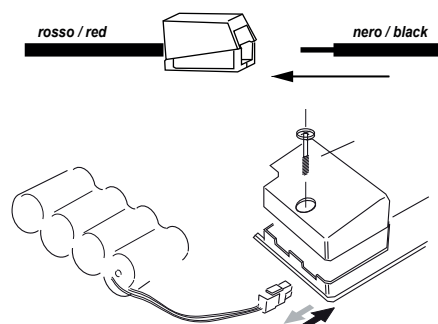

- For the wiring please refer to enclosed wiring diagrams.
- Great attention must be paid to polarity during the installation of the battery.
- Keep batteries away from heat sources (away from magnetic battery).
- In order to check the correct functionality we commanded charging of about 30 hours.
- Install the product contains an emergency kit within 15 days from receipt of the products.
- For prolonged storage make sure that the battery cable is disconnected.
- This system is made to be powered only with the supplied batteries: do not connect any external battery charger.
- It is advisable to effect periodically (every 3 month) at least one discharge and charge cycle in order to assure the max efficiency.
- Replace the battery every 4 years or after 500 charge/discharge cycles.
- Before every maintenance operation, disconnect all mains.
- This product contains materials which could be toxic if improperly disposed in the environment.



INSTALLAZIONE DELLA GRIGLIA DI PROTEZIONE

1) Fissare la griglia al proiettore rispettando il sensomostroato nel disegno accanto. Il distanziale basso va rivolto dalla parte della staffa (vedi disegno).
2) Accertarsi che le quattro molle a pressione siano correttamente in posizione.

3) Utilizzare una fascetta metallica con occhiello (fornita nella confezione) per allacciare le due estremità e garantirne così la tenuta. Torcere la fascetta con una pinza in modo da tendere la fascetta sulla griglia.

ATTENZIONE: non è possibile garantire la tenuta della griglia senza un sistema di ritenuta, come fasciette o molle.

INSTALLATION OF THE PROTECTION GRID

1) Fix the grid to the floodlight respecting the direction in the drawing.

The low spacer should be facing the side of the bracket (see drawing).

2) Make sure that the four pressure springs are correctly in place.

3) Use a metallic clamp with eyelet (supplied in the package) to fasten the two ends and thus ensure tightness. Twist the clamp with pliers to stretch the clamp on the grid.

ATTENTION: it is not possible to guarantee the tightness of the grid without a restraint system, such as bundles or springs.
